Issues/Concerns (including fiscal, legal, and compliance impact):

- Military-affiliated benefit programs are complex, and it is impossible to enumerate all the information regarding how they operate. Consequently, this policy should focus on
 - o topics that are most impactful to military-affiliated students,
 - o important actions that military-affiliated students should take or not take with respect to their education and education benefits, and
 - o information that government entities encourage or require to be published and made publicly available to military-affiliated students.
- There is always a risk that a student will be adversely affected by a benefit process or procedure that is not explicitly mentioned in the policy. We make every attempt to inform students about how they may be negatively affected by processes and procedures, but ultimately rely on students to communicate with university employees about questions they have and the possibility of issues that affect them.
- This policy should be consistent with the guidance on benefit and program administration contained in the following sources:
 - VA School Certifying Official Handbook
 - o VR&E School Certifying Official Handbook
 - o Title 38 US Code
 - Special attention to:

Suggested Changes:

- 1) Change the policy title to "Veteran and Military-Affiliated Services."
- 2) Expand and update the policy so that it contains language similar to the current Military-Affiliated Student Hub (MASH) User Agreement that Veterans Affairs (VA) benefit recipients agree to, as well as the MASH language in the UVU Catalog. The MASH User Agreement includes language regarding organization roles, applications, communication, transcripts, residency, processing time, enrollment changes, approved courses, course repeats, credit hours and rate of pursuit, grades, tutoring, reporting changes, educational opportunity center, payment of entitlement, flight program, new student documentation, etc.
- 3) Expand the policy to include language regarding Department of Defense (DoD) and Utah State benefit programs, as well as other procedures and programs relevant to military-affiliated students.
- 4) Design the language to support UVU's compliance efforts with VA, DoD, and state requirements.
